We are also implementing exciting new programs that will be rolling out this year. Read on to learn more about these programs.

## The NCSF Ambassador Program

A NCSF Ambassador is a passionate member of our Society that would like to take their enthusiasm to the next level.

#### An Ambassador:

- Helps spread the word about NCSF and the good works that Courts do in their communities.
- · Is a good speaker.
- Understands good public relations.
- · Attends community events.
- · Educates the community about NCSF.
- Becomes a representative of NCSF at their local Chamber of Commerce.

Volunteers for the Ambassador program will be properly trained by the Outreach and Engagement staff. Ambassadors receive all the tools and materials needed to be a NCSF Ambassador. An Ambassador will receive a stipend of \$250 per quarter. The Ambassador must report on all community events attended per quarter. The report will include photos of events attended as well as a write-up that can be used for inclusion in community newspapers and social media.

NCSF has a rich history of philanthropic work within communities. As NCSF continues to mature as a Society, we realize that our Court system is maturing as well. Many Courts may have the will to continue to meet as a group but may no longer be active. If a Court has a desire to continue to meet on a strictly social level, they will not need to close. They may be considered "Social Courts."

Social Courts are inactive and may be comprised of beneficial and social members that gather as a group on a friendly community level to share and enjoy camaraderie and companionship. Members of Social Courts may also participate in the name of NCSF in community activities and events.

A Court that desires to stay together instead of closing must complete a Social Court application. Once the application is approved, the Social Court will receive a stipend of \$100 per year to help with their meeting costs. Social Courts will not be eligible for any other Court renumerations like operating expense, activity funds, grants, Hearts & Hands matching funds etc. Social Courts may however be eligible for the Pop-Up Impact Team benefit if they wish to conduct an event.

## NEW PROGRAM FOR 2020 NCSF Pop-Up Impact Teams

Find the Pop-Up Impact Team Application on our website www.ncsf.com.

Available to individual beneficial members only. All beneficial NCSF members are eligible to lead a NCSF Pop-Up Impact Team to create an event that will benefit their community or a cause that is NCSF approved. This member may gather their friends and family together to create an event.

**The Project:** 

- The project must benefit the community where the member lives, works or worships.
- NCSF Pop-Up Impact Teams are not intended to be self-benefiting for the member or their immediate family.
- As the member applying, they must actively be contributing to the success of the project.
- NCSF Pop-Up Impact Teams should not be "donated" to others for implementation.
- Member leaders need to be actively participating in the generosity of this program.
- Volunteers must be contributing time and talent to make a difference in the community.

The initiator of the Pop-Up Impact Team must complete a Pop-Up Impact Team Application.

Once approved, the NCSF Home office will send out a Pop-Up Impact Team box containing t-shirts, banners and other appropriate marketing material along with a \$250 pre-paid VISA card for seed money. The money must be used for event costs only.

The seed money must be spent within 120 days from receipt/activation. The card will not be active after this time period. Any unused seed money will be returned to NCSF. The beneficial member leader of the team must complete an event report form directly after the event, as well as submit pictures of the event itself.

Beneficial members are eligible to lead two NCSF Pop-Up Impact Teams per calendar year. You must be 16 years or older to lead a NCSF Pop-Up Impact Team.

#### Revise your estate plan to reflect life changes during the past 12 months

As the calendar turns to a new year, it's an excellent time for a person to review his or her estate plan. Never intended to be static, the plan should be considered a work in progress. Let's take a look at life-changing events that can affect your estate plan.

#### Have your circumstances recently changed?

Your circumstances could be affected by certain life events that should be reflected in your estate plan. And the plan should be reviewed periodically anyway to ensure that it still meets your main objectives and is up to date.

What sort of life events might require you to update or modify estate planning documents? The following list isn't all-inclusive by any means, but it can give you a good idea of when changes may be required:

- » Your marriage, divorce or remarriage,
- » The birth or adoption of a child, grandchild or great-grandchild,
- » The death of a spouse or another family member,
- » The illness or disability of you, your spouse or another family member,
- » When a child or grandchild reaches the age of majority,
- » When a child or grandchild has education funding needs,
- » The death of the person named as guardian for minor children in your will, your personal representative or the trustee of your trust,
- » Changes in long-term care insurance coverage,
- » Taking out a large loan or incurring other debt,
- » Sizable changes in the value of assets you own,
- » The sale or purchase of a principal residence or second home.
- » A significant promotion at work or change in job circumstances,
- » Your retirement or retirement of your spouse,
- » Receipt of a large gift or inheritance,
- » The sale of a business interest, or
- » Changes in federal or state income tax or estate tax laws.

If you have minor children, your will should designate a guardian to care for them should you die prematurely. It should also make certain other provisions, such as creating trusts to benefit your children until they reach the age of majority, or perhaps even longer.

Your durable power of attorney authorizes someone to handle your decisions relating to your financial affairs if you're disabled or otherwise unable to act. Likewise, a medical durable power of attorney authorizes someone to handle your medical decision making in those circumstances.

Typically, these powers of attorney are coordinated with a living will and other health care directives. The powers of attorney expire on your death. A living will spells out your wishes concerning life-sustaining measures in the event of a terminal illness.

Although a letter of instruction isn't legally binding, it can be incredibly useful. The letter may provide an inventory and location of assets; account numbers for securities, retirement plans, IRAs and insurance policies; and a list of professional contacts that can help your heirs after your death. It may also be used to state personal preferences (for example, specifics for funeral arrangements).

#### Are you ready for the new year?

The end of the year is a natural time to reflect on the previous 12 months and to review and revise your estate plan — especially if you've experienced major life changes. Your estate planning advisor can help determine if any changes are needed as 2020 gets under way.

#### **Continuing Education**

Are you interested in learning a new skill... Like how to use a computer, social media, cooking, or a new language? Do you have an interest in photography, ceramics, or another hobby? Then the Continuing Education Grant is for you!

Members aged 26 and older who have met eligibility requirements can apply for one of 10 grants that will award up to \$250 each for any credit or non-credit course offered at a local community college, park district, senior center, or other approved institution, including instructor required supplies\*! That means if the course is \$190 and required supplies cost \$50, the grant will cover the entire \$240 expense. Anything over \$250 would be your responsibility to pay.

**Deadline is May 31.** The applicant must be a beneficial member of the Society for two full years by application deadline. Certificates must be in force and active. The continuing education grants will be chosen lottery style. Please complete the application form below. #### Catholic Grade School Grants - \$300 each

Members entering kindergarten through eighth grade may apply. Recipients may reapply the following year, except for eighth-graders. Funds are made payable directly to the recipient's Catholic school.

#### Religious Education Grants (CCD) - \$50 each

Only members of NCSF in grades K-11 and enrolled in a parish-sponsored education program may apply. Funds are made payable directly to the parish.

Moving forward, we would like to share and draw attention to the accomplishments of Courts and Impact Teams that have proven a long-term commitment to their community with projects large and small.

Funds were donated to or towards: air conditioner for the church, handicap access to the church, tuckpointing the rectory, playground equipment for the school, TIC Camera for Paris-Dickeyville Fire Department, grotto cement sidewalk replacement, restoration of cemetery stones, grotto maintenance, refurbishment of the Schaefer pipe organ, Dickeyville Rescue Squad special gear, blower for pipe organ, rectory windows, kitchen dishwasher, redecorating of the church, crucifixion group grotto in the cemetery, church roof repair, grotto patriotic shrine water fountain, repair of church windows, new electric votive light stand with candles, campus window replacement, releading of church windows, blacktop repairs for school, grotto pavilion repair, signage for the deceased with no tombstones in cemetery, church repair of elevator and railing, patriotic shrine fountain repair.

# 4 Things You Didn't Know Life Insurance Could Do

When you think of life insurance, what usually comes to mind is the death benefit — the amount of money that is paid out to your beneficiaries when you die. And that certainly is the main reason most people get life insurance.

Keep in mind, however, that there are two major types of insurance. Term life insurance provides protection for a specific period of time (the "term") such as 10 or 20 years, and generally pays a benefit only if you die during that term.

Permanent life insurance, by contrast, provides lifelong protection, as long as you pay the premiums. Because it is designed to last a lifetime, permanent life insurance generally accumulates cash value. That means there are some important living benefits to permanent life insurance, benefits you can take advantage of to fund life's possibilities.

## Here are four things you probably didn't know you could do with permanent life insurance:

#### 01 Fund a college education.

Over time your policy accumulates cash value, and you can borrow against the cash value and use it to help pay for college or other secondary education. Actually, you can use the money for anything you want, but the example here is paying for college. No applying for loans from the bank. No financial aid forms. Just ask for the money and it's yours.

You can borrow against the cash value and use it to help pay for college or other secondary education.

Tapping the accumulated cash value of your policy will have an impact on your death benefits, so be sure to discuss your plans with your financial advisor.

#### 02 Start a business.

The hard fact of starting a business is that banks don't lend money to businesses without revenue. This means you need to fund the business yourself, either from your own savings or by borrowing from friends and family. One often overlooked source of funds for a new business is the cash value of your life insurance policy. If Walt Disney can borrow from his life insurance to create Disneyland, you can use your life insurance to make your dreams come true too.

#### O3 Take time off to care for an ederly parent.

A work colleague of mine talks about how fortunate she was to be able to step out of work earlier in her career to spend time attending to family matters. She was able to do that in part because she could tap into the accumulated cash value of her life insurance policy.

Unlike sending a kid to college or starting a business, you can't control the timing of these sorts of family emergencies, but you can make sure you are prepared financially when it happens.

#### **04** Grow your 401(k).

Because of the safety provided by your life insurance policy, you might be able to take a more aggressive allocation strategy in your 401K investments. Also, because you can tap into the cash value of your insurance policy to cover those first few years of retirement, you can let the funds in your 401(k) grow much longer.

These ideas aren't right for everyone. I mention them here merely to illustrate some of the ways other people have made use of the living benefits of their life insurance. Talk to your financial and professional advisors to ensure they are appropriate for your situation, but know that life insurance is for more than just paying out a death benefit.

# A Message from Father Panek



Winter has a way of slowing things down.

Traffic is slowed with the occasional snow or ice, so is the rhythm of our life and health. Usually by Thanksgiving our minds are preparing for the next season, winter weather, holiday activities and a new year.

This past Halloween a good portion of our country was blanketed with snow and ice followed by an unexpected Artic blast. Here in the Midwest, ponds and streams were frozen over, roadways and walkways were covered with ice which made it difficult to pass and move forward. What an inconvenience! Honestly, I am amazed at the strength and dynamism of such forces that touch our human activity.

Frozen is the word that comes to mind describing this circumstance, and the feeling that is associated with it is isolation.

Disney studios have some talented people working for them. A few years back the popular story and film Frozen was released. It examined fear as it touched a young girl named Elsa. The story revealed how fear can freeze our capacity to live and be connected to one another, how its force in our lives can literally freeze our momentum to seek out life's purpose and gifts. What an appropriate image to reflect on in our faith and spirituality.

Our faith tradition has much to say on this topic of fear. Anxiety and isolation come from this sense of "frozenness."

First a disclaimer. I have read books and viewed data via the Internet that peddle the idea that fear and its other manifestations are from the devil. It gives the impression that if we experience fear

it is because of this adversary at work. That is a poor and simplistic understanding of human nature, let alone a religious reference point.

First and foremost, fear and anxiety are mostly primal human reactions to various situations. More importantly, the hallmark of God's activity is to save us, to be on our side, to lead us forward regardless of fear, anxiety, or any brokenness. We call that action God's love, Jesus! Yes, the world has been and is frozen at times. It is oftentimes selfish, fearful and judgmental. That sums up the 'bigger picture' of human salvation, God's initiative is always to save and set free. The work of the divine is to transform and bring forth from us a fuller and deeper life, a life of communion and fellowship.

Then there is the 'little picture' of you and me and our place in this drama of salvation. Here our grounding is that our faith — especially our personal faith — in God helps remove the obstacles, challenges and fears in our unique individual lives. It is not only characterized by faith; it is the personal place of choosing to respond and exercise our desire to let God do God's work. It reminds us that we have a personal responsibility to claim our salvation, to be free, holy and beloved. Relating this from a religious perspective, only the fire of God's love can purify and overcome our fears, burdens and isolation.

Disney got it right, only the act of true love can thaw a frozen heart and its predicament. I think the wisdom here is that we cannot do it on our own. We need others — friends, groups and that sweet powerful spirit of God that is like a warm fire on a chilly night working through it all.

It is no wonder that the angels spoke to our predecessors at critical times, "Do not be afraid." LUKE, 1, 28-36, MATT 1, 18-24, as well as many other examples.

If we listen, we may hear them speaking to us now.
